I wish to inform the Government that the District Educational Officer, Hyderabad vide reference 1<sup>st</sup> cited has submitted the proposals for issue of No Objection Certificate and for affiliation of Amritha Vidyalayam, Mahendra Hills, East Marredpally, Secunderabad to Central Board of Secondary Education, New Delhi. The Regional Joint Director of School Education, Hyderabad vide reference 2<sup>nd</sup> cited has also recommended for issue of No Objection Certificate and affiliation of the school to Central Board of Secondary Education, New Delhi.

In this connection, I submit that the proposals have been examined with reference to the Bys Laws of the Central Board of Secondary Education, New Delhi. The management have deposited Rs. 60,000/- in the Joint Account of the Secretary, Central Board of Secondary Education, New Delhi and Correspondent, Amritha Vidyalayam, Secunderabad vide FDR No. 240132, dated. 9-9-2004 which is due on 9-9-2009.

Hence, I request the Government kindly to issue No Objection Certificate in respect of Amritha Vidyalayam, Mahendra Hills, East Marredpally, Secunderabad for affiliation of the School to Central Board of Secondary Education, New Delhi, subject to the following conditions;

- i) they should follow Three Language Formula.
- ii) They should follow the rules and regulation of the Government of Andhra Pradesh issued from time to time.
- iii) They should pay salaries to the staff as per rules.

In view of the above, I am herewith submitting the proposals in duplicate (one original copy of one Xerox copy alongwith its enclosures) with a request to forward the same to the Secretary, Central Board of Secondary Education, New Delhi alongwith No Objection Certificate for affiliation of the school to Central Board of Secondary Education, New Delhi.




